











1. Remove product from box and identify all parts as shown in FIGURE 1. For extra security, see step 4 prior to assembly.




**2.** Measure your ceiling height and select the appropriate configuration shown in *FIGURE 2*. Stack each part starting with **A** and ending with **I**. All parts are tapered to fit together, narrow end up, wide end down.

**NOTE:** For all configurations, plastic Sleeve F must be installed after E to ensure the threads on D are covered after full installation. Also, for all but the tallest configuration, there will be extra parts which should be kept incase you move this product.





3. Ensure that the product is completely vertical (plumb), use a level if necessary, and that the handle is in the direction you want it to stay in. While holding **F** up to expose the threads and nut, align the set screw in the metal cone with the flat surface in the threads. Then rotate the nut on **D** counterclockwise using **J** as shown in *FIGURE 3*. The nut will move up to tighten the product against the ceiling. The product must be secured between the floor and ceiling with ABSOLUTELY NO sliding of the product between them. Tighten the set screw using tool **K**. Then slide **F** down to cover the threads. **Caution:** Do not overtighten as doing so may damage the ceiling, or this product.

4. OPTIONAL: Use provided screws, L, ensuring L goes into the Ceiling Joists as shown in FIGURE 4.
